Aim

Methods

Admissions

Our pre-school is open to all members of the community.

- We advertise our service widely in places accessible to all of the community.
- We reflect the diversity of members of our community in our publicity and promotional materials.
- We provide information in clear, concise language, in whatever form suits peoples needs best.
- We provide information in as many languages as possible, when required.
- We base our admissions policy on a fair system.
- We ensure that all parents are made aware of our equal opportunities policy.

 We develop an action plan to ensure that people with disabilities can participate successfully in the services offered by the pre-school and in the curriculum offered.

Employment

- Posts are advertised and all applications are judged against explicit and fair criteria.
- The applicant who best suits the criteria is offered the post, subject to references and checks by the Criminal Records Bureau. This ensures fairness in the selection process. All job descriptions include a commitment to equality and diversity as part of their specifications.
- We monitor our application process to ensure that it is fair and accessible.

Training

- We seek out training opportunities for staff and volunteers to enable them to develop practices which enable all children to flourish.
- We review our practices to ensure that we are fully implementing our policy for equality and diversity.

Curriculum

The curriculum offered in the pre-school encourages children to develop positive attitudes to people who are different from themselves. It encourages children to empathise with others and to begin to develop the skills of critical thinking.

We do this by:

- Making children feel valued and good about themselves;
- Ensuring that children have equality of access to learning;
- Reflecting the widest possible range of communities in the choice of resources;
- Avoiding stereotypes or derogatory images in the selection of materials;
- Celebrating a wide range of festivals, with contributions from the children and families if they
 wish to do so;
- Creating an environment of mutual respect and acceptance;
- Helping children to understand that discriminatory behaviour and remarks are unacceptable;
- Ensuring that the curriculum offered is in line with the EYFS and nurtures children's individual journey to learning;
- Ensuring that children whose first language is not English have full access to the curriculum and are supported in their learning.

Valuing Diversity in Families:

- We welcome and value the diversity of family life and work with all families.
- We encourage children to contribute stories of their everyday life into the Pre-

Food
